

# Nominations for Officers of The GIMA (1999) Ltd. Council for 2013/2014

Paragraph 8 of the Articles of Association of GIMA (1999) Ltd states that the number of members constituting the officers and Council of Management shall not exceed sixteen. Of the existing Council of twelve, at least four are required to retire by rotation as set out in Paragraph 13a of the Articles. This is on a "first in, first out" basis. This represents one third of the Council.

This needs to be completed in full and returned to the GIMA office to arrive no later than 13th March 2013.

Should the number of nominations exceed vacancies, a voting form will be sent to you prior to the AGM. In such an eventuality, the voting form should be returned at least 7 days prior to the AGM, (3<sup>rd</sup> April 2013). The AGM takes place on 10<sup>th</sup> April 2013.

The definition of a *full member* is an eligible company whose membership fees for the current year are fully paid up.
